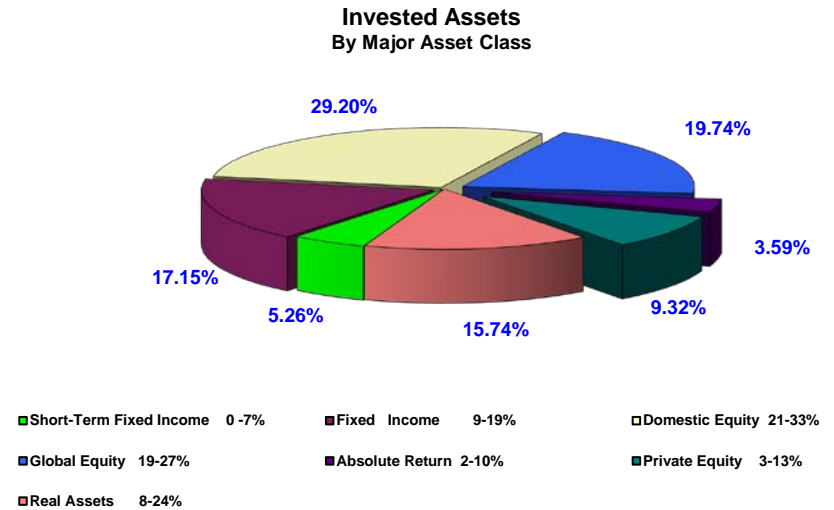
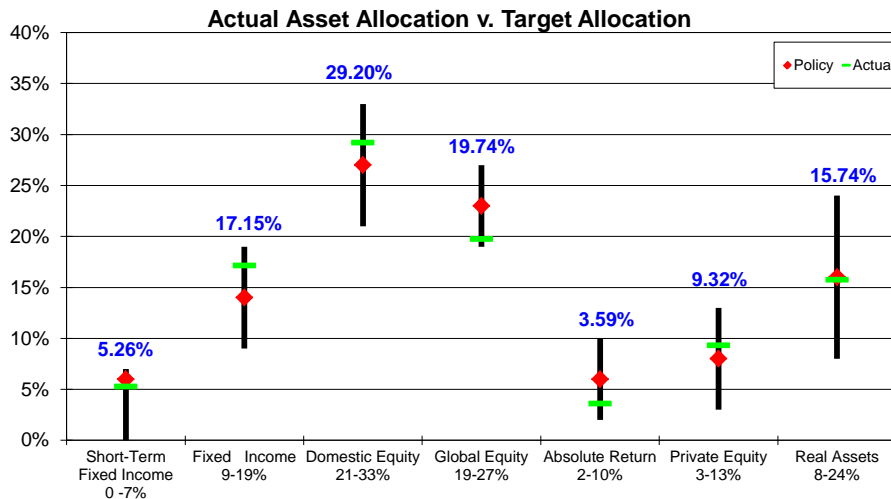
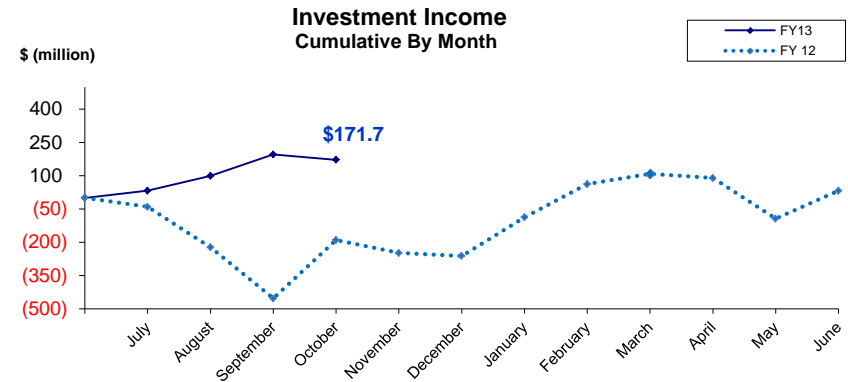
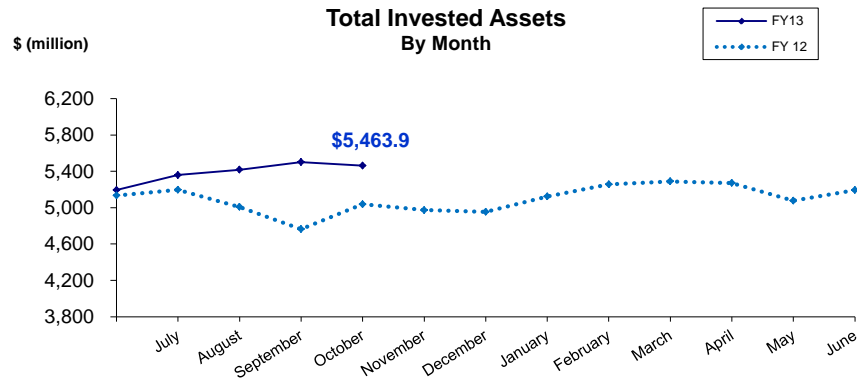
PUBLIC EMPLOYEES' RETIREMENT TRUST FUND

As of October 31, 2012



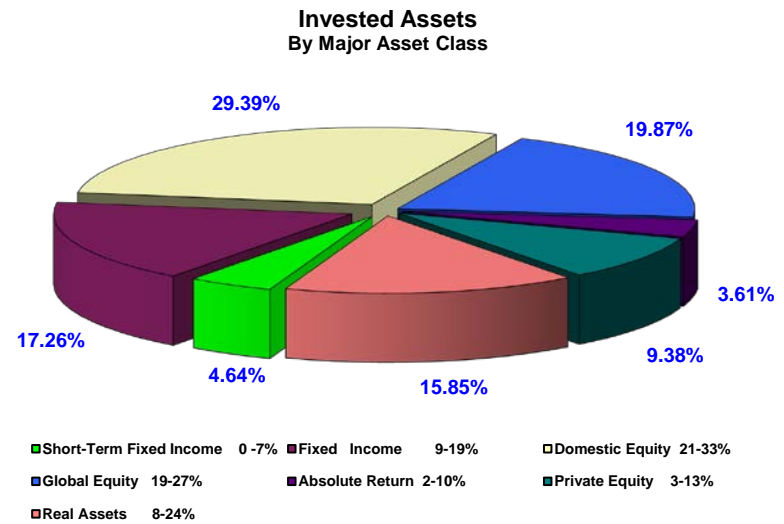
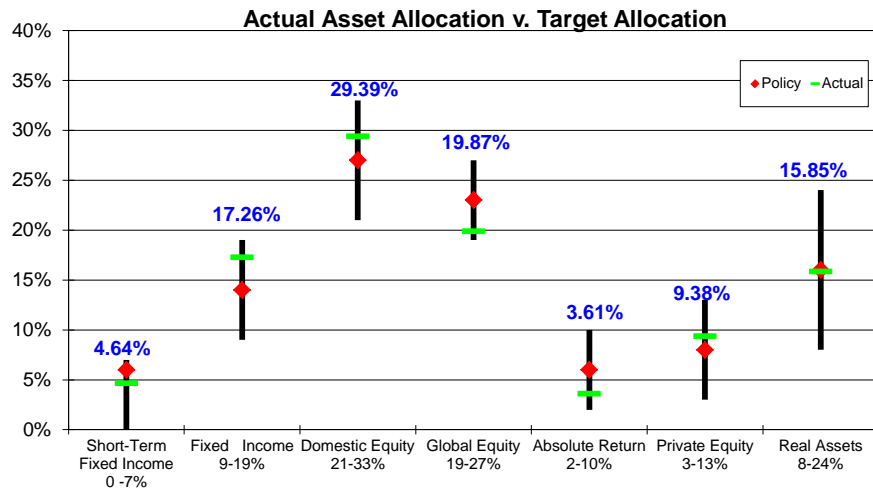
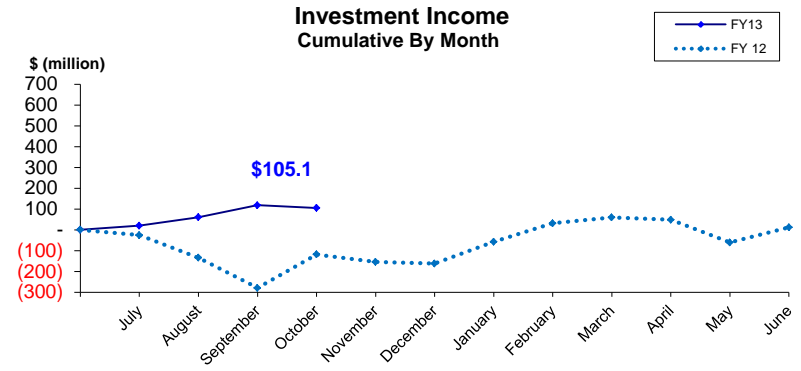
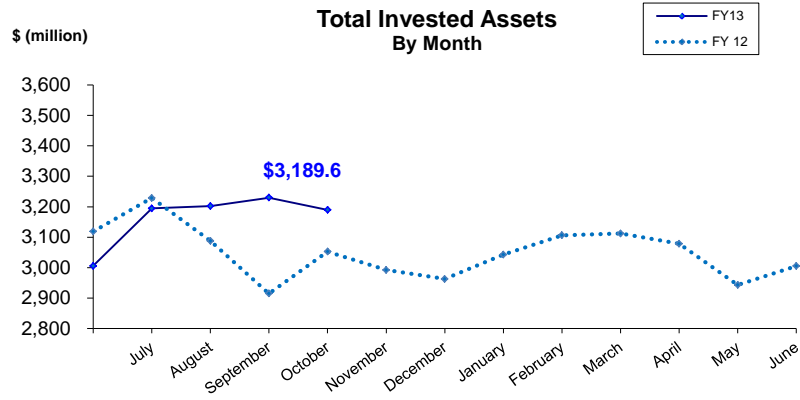
PUBLIC EMPLOYEES' RETIREE HEALTH CARE TRUST FUND

As of October 31, 2012



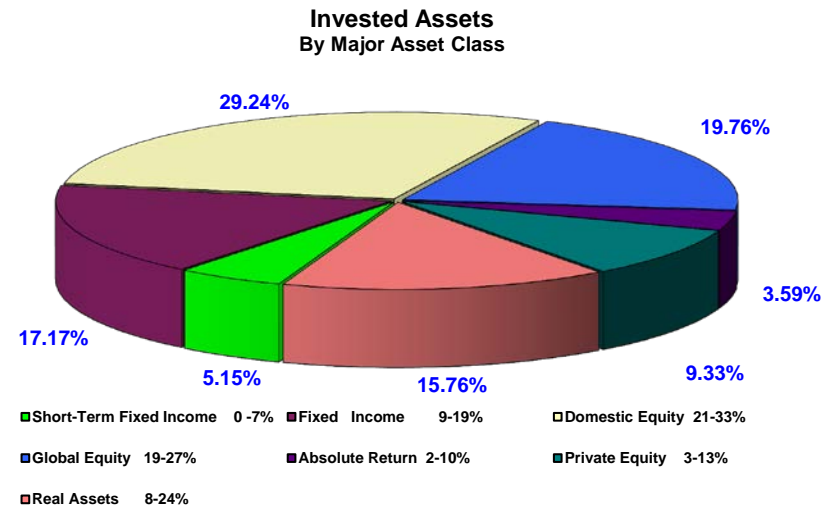
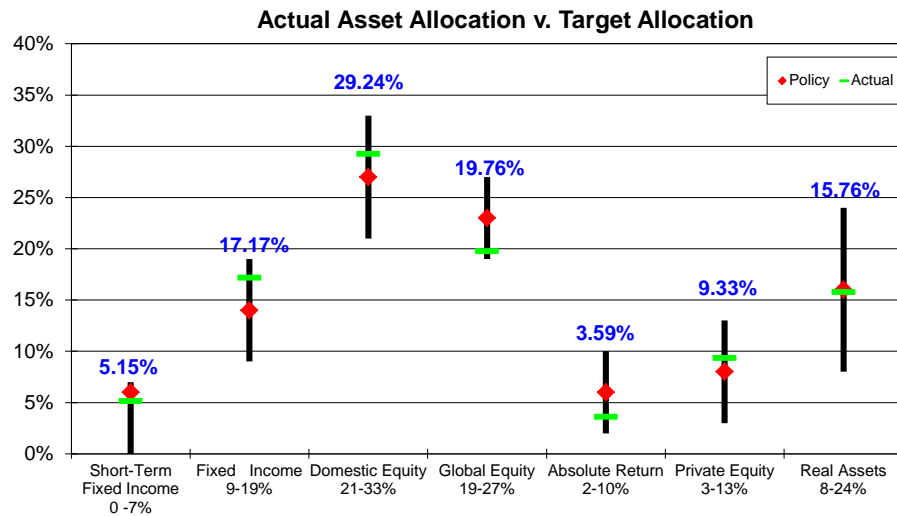
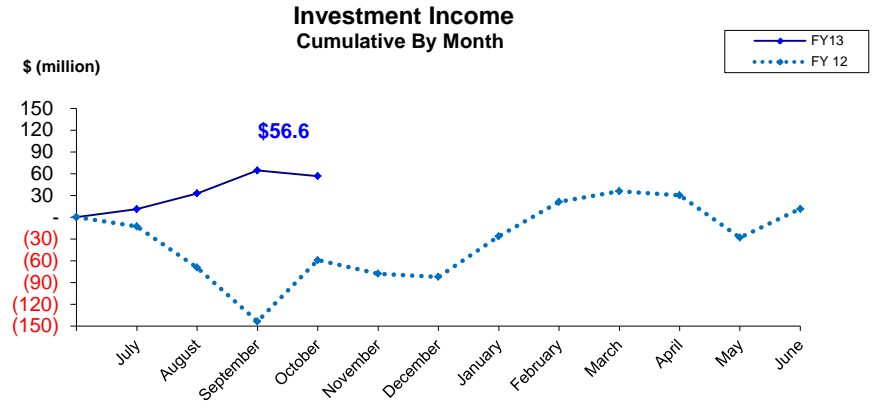
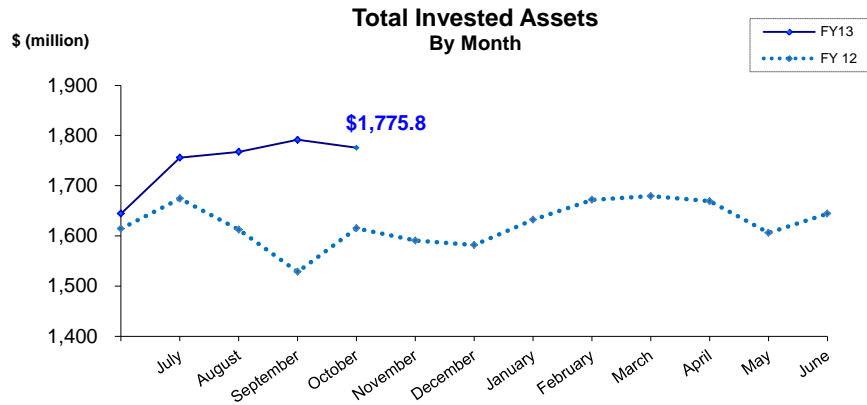
TEACHERS' RETIREMENT TRUST FUND

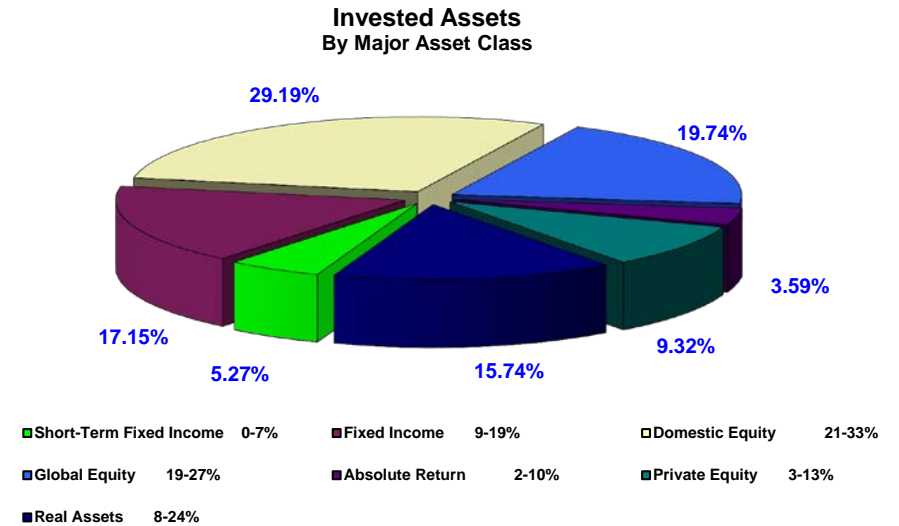
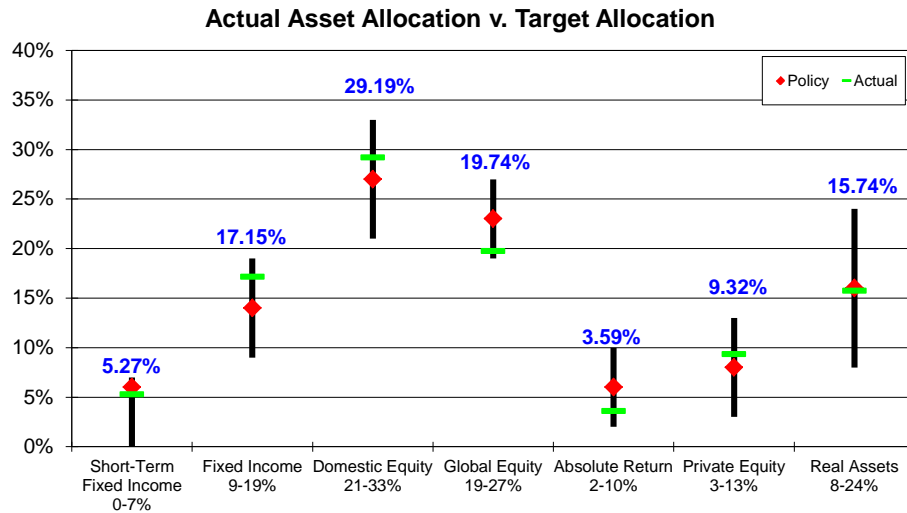
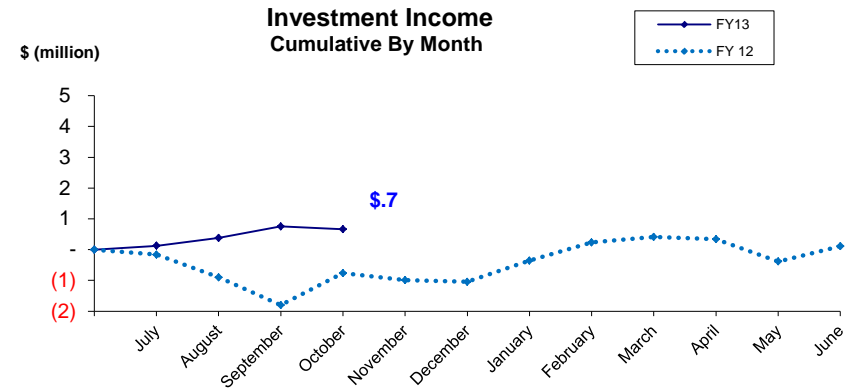
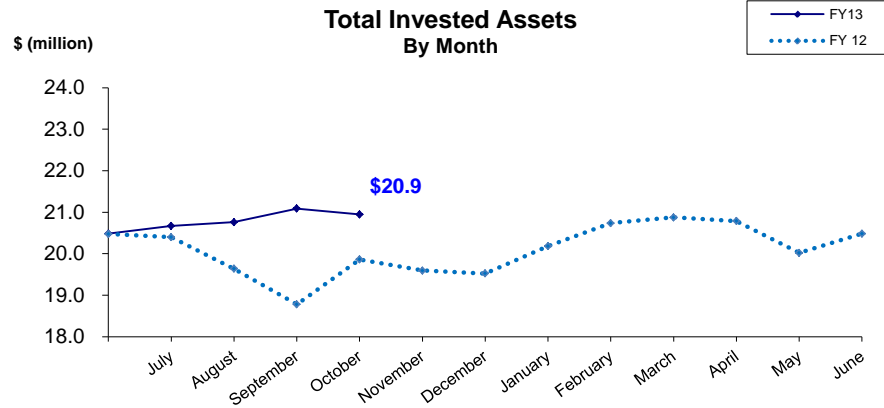
JUDICIAL RETIREMENT TRUST FUND
