




PUBLIC EMPLOYEES' RETIREMENT TRUST FUND As of November 30, 2012




PUBLIC EMPLOYEES' RETIREE HEALTH CARE TRUST FUND As of November 30, 2012




TEACHERS' RETIREMENT TRUST FUND As of November 30, 2012




TEACHERS' RETIREE HEALTH CARE TRUST FUND As of November 30, 2012




JUDICIAL RETIREMENT TRUST FUND As of November 30, 2012
