




## PUBLIC EMPLOYEES' RETIREMENT TRUST FUND As of January 31, 2013




## PUBLIC EMPLOYEES' RETIREE HEALTH CARE TRUST FUND As of January 31, 2013




## TEACHERS' RETIREMENT TRUST FUND As of January 31, 2013




## TEACHERS' RETIREE HEALTH CARE TRUST FUND As of January 31, 2013




### JUDICIAL RETIREMENT TRUST FUND As of January 31, 2013
