


Total Defined Benefit Assets As of May 31, 2017

Fiscal Year-to-Date through May 31, 2017




Public Employees' Retirement Health Care Trust Fund

Fiscal Year-to-Date through May 31, 2017




Teachers' Retirement Pension Trust Fund

Fiscal Year-to-Date through May 31, 2017




Teachers' Retirement Health Care Trust Fund

Fiscal Year-to-Date through May 31, 2017




Judicial Retirement Pension Trust Fund

Fiscal Year-to-Date through May 31, 2017




Judicial Retirement Health Care Trust Fund
