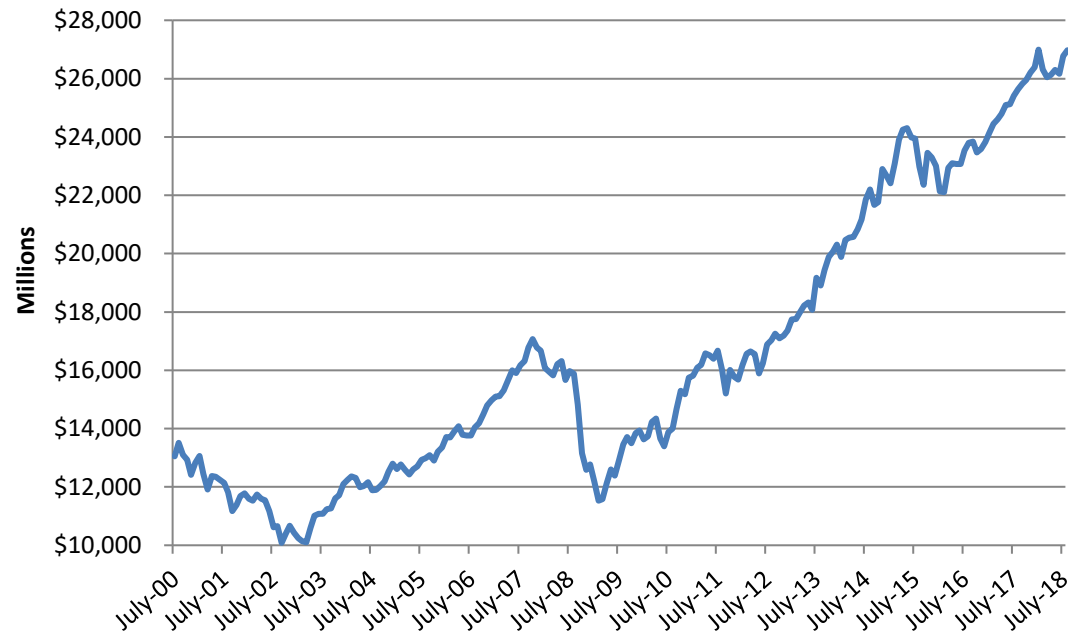

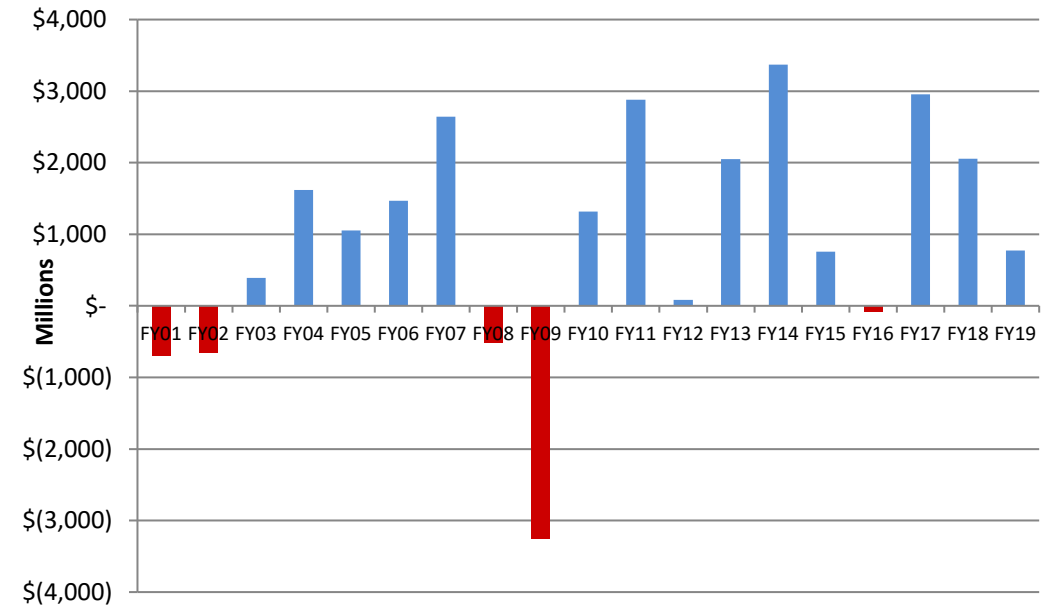

Total Non Participant Directed Assets As of August 31, 2018

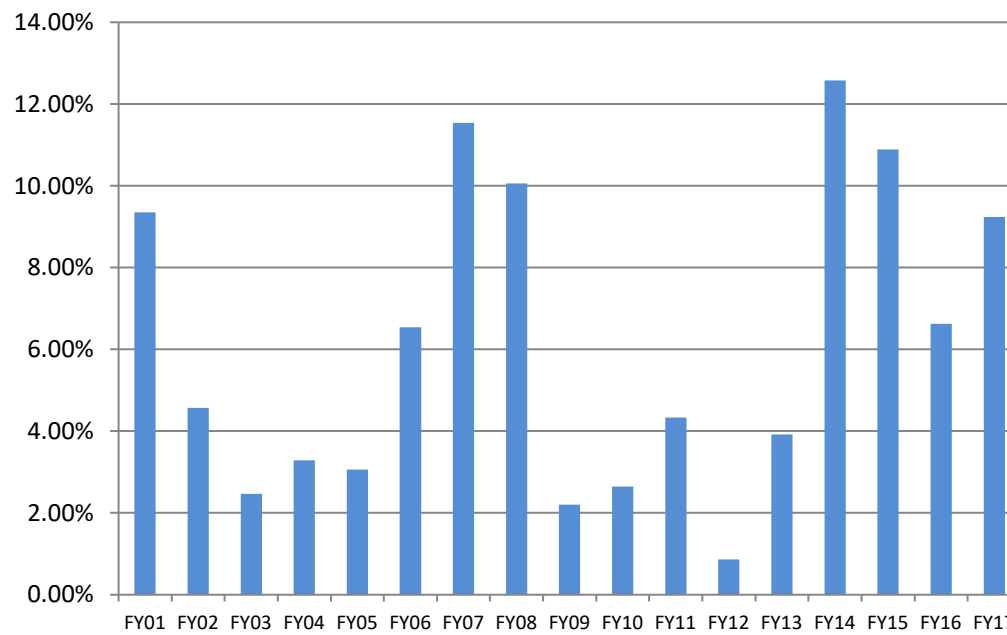
Total Assets History



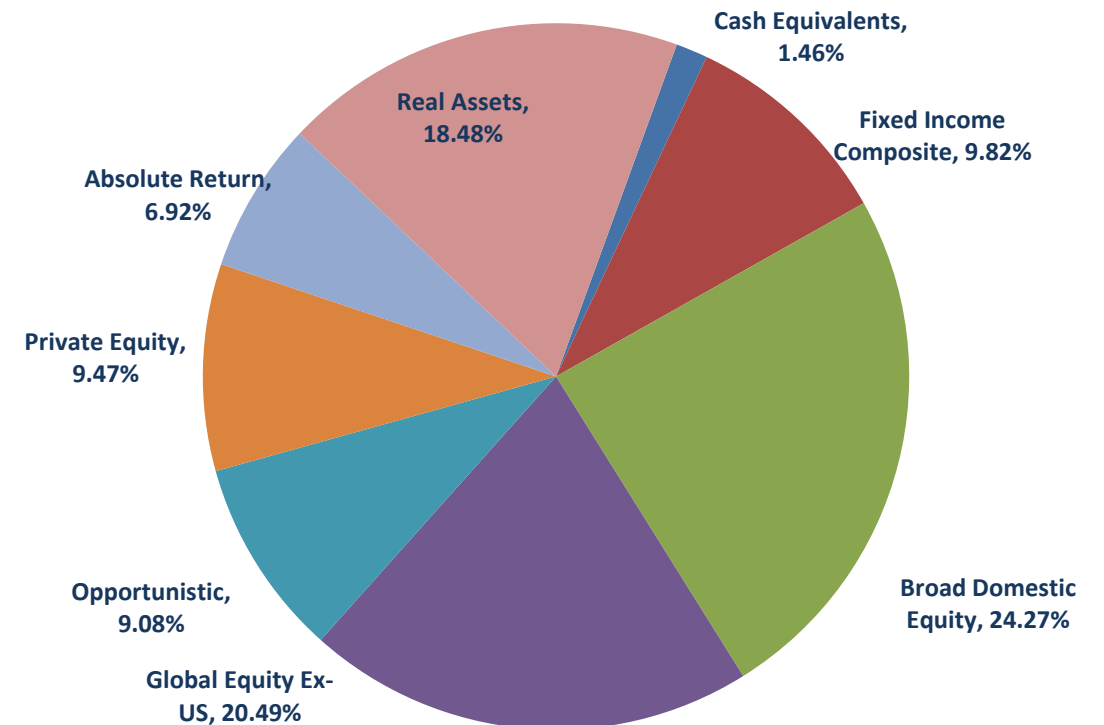
Income by Fiscal Year



5-year Annualized Returns as of Fiscal Year End



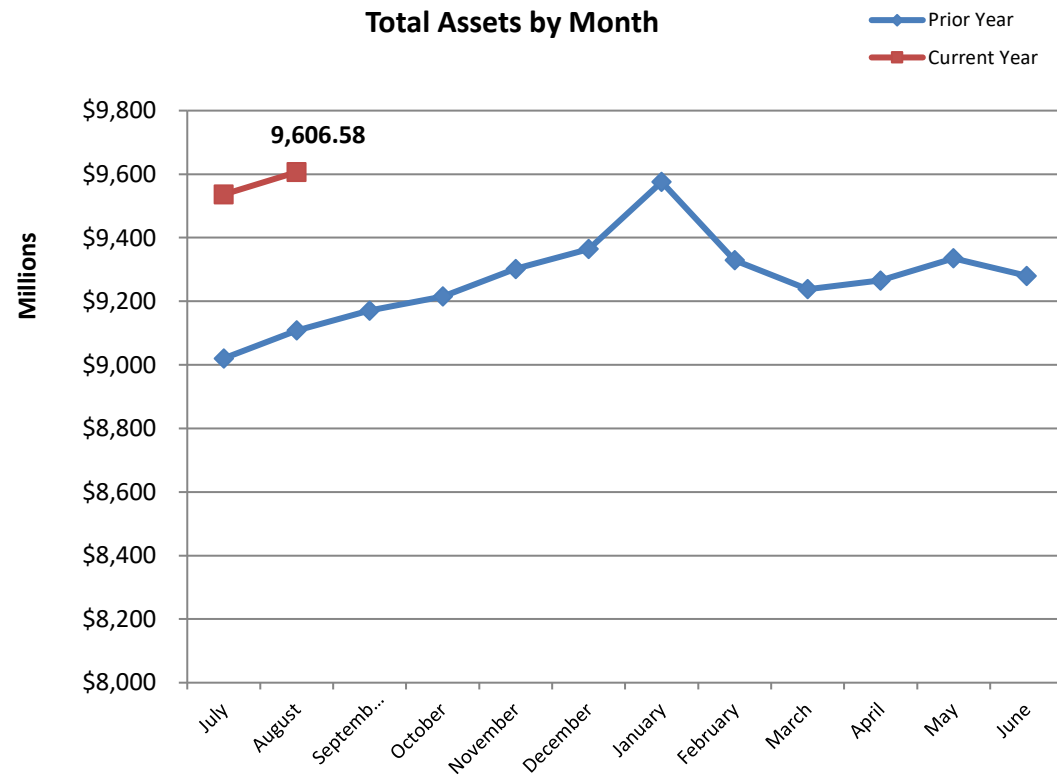
Actual Asset Allocation



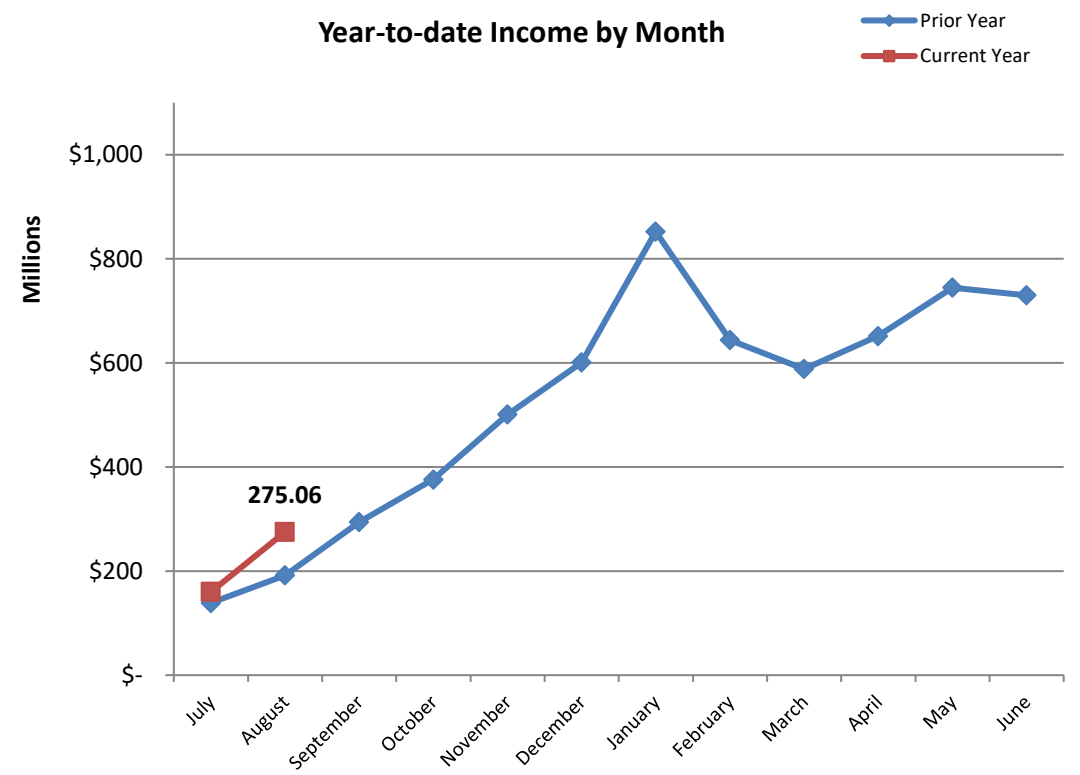

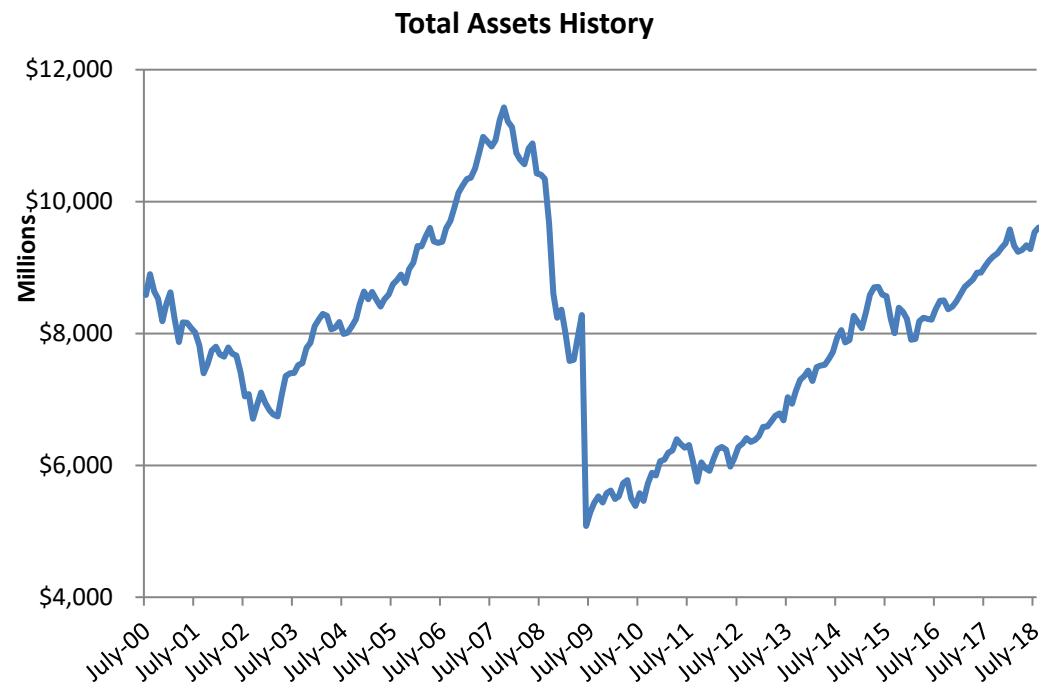
Total Assets by Month



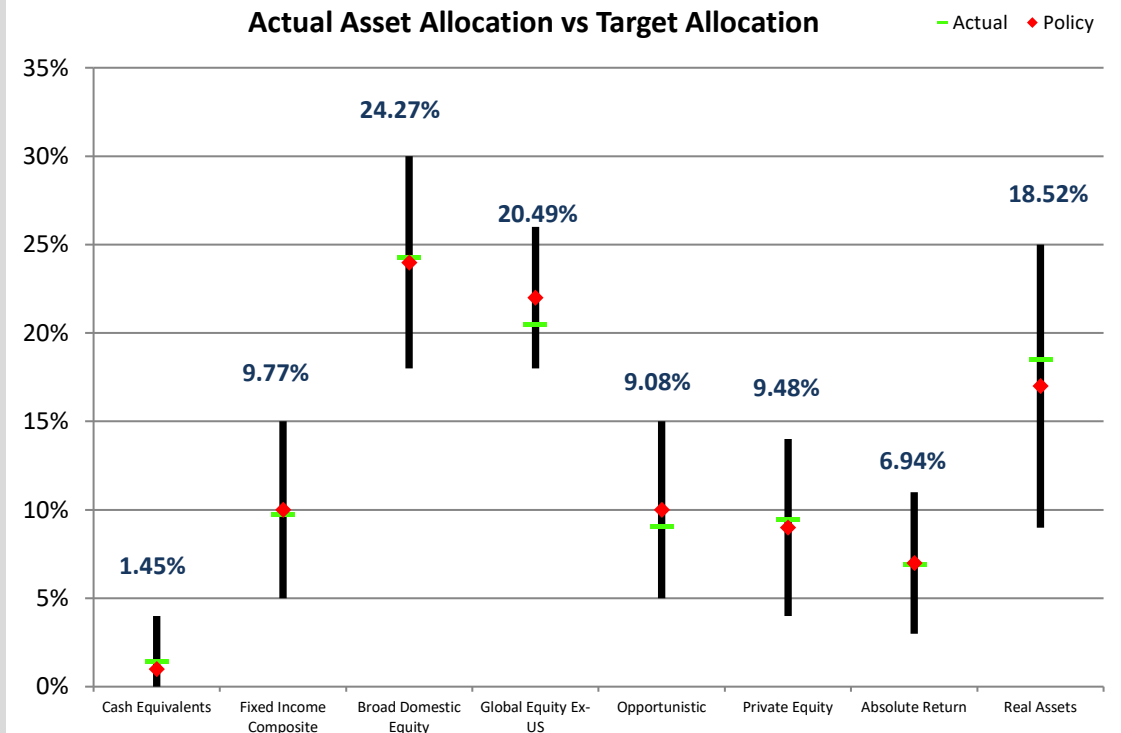
Year-to-date Income by Month

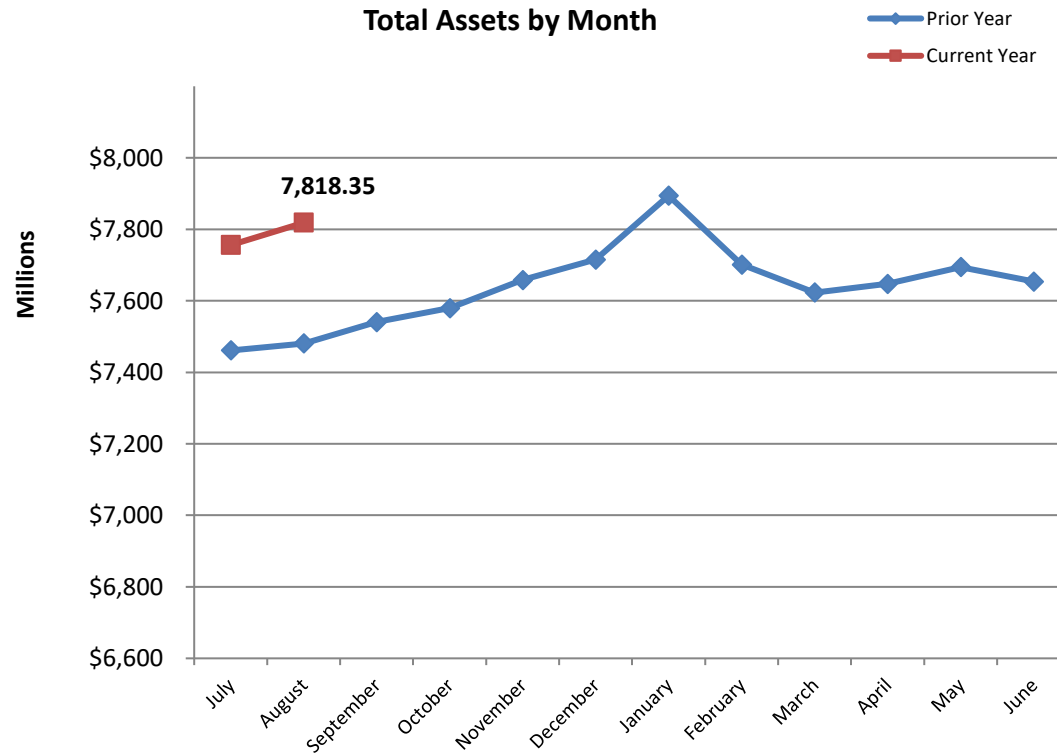
Actual Asset Allocation vs Target Allocation



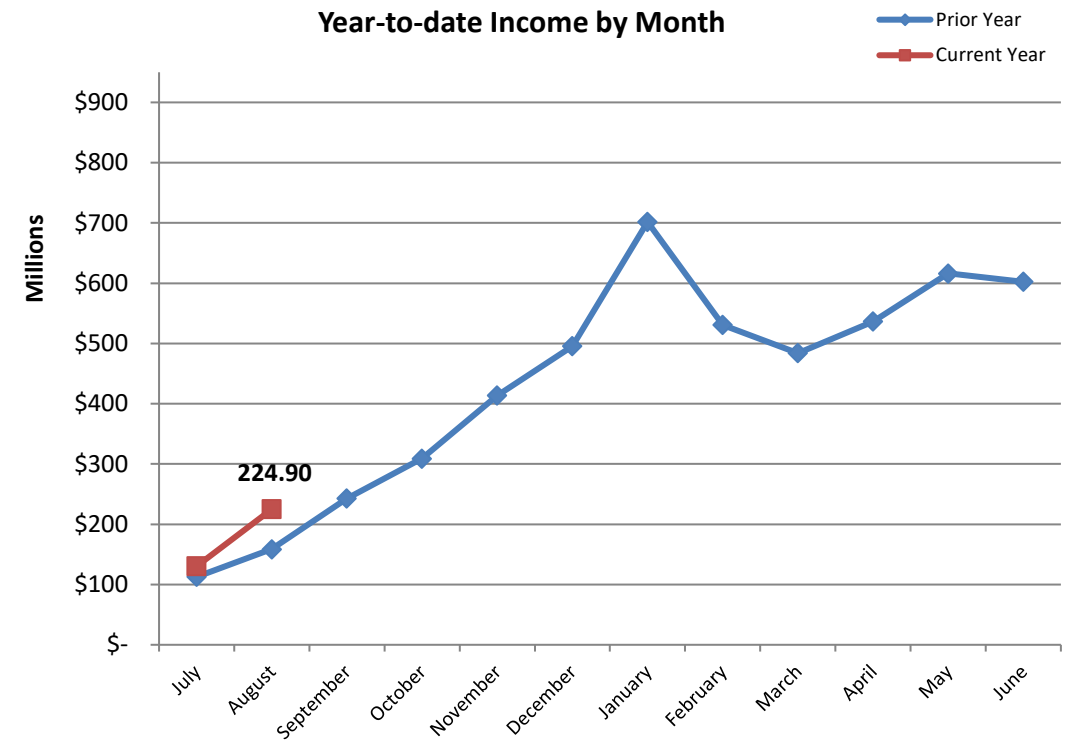

Actual Asset Allocation vs Target Allocation

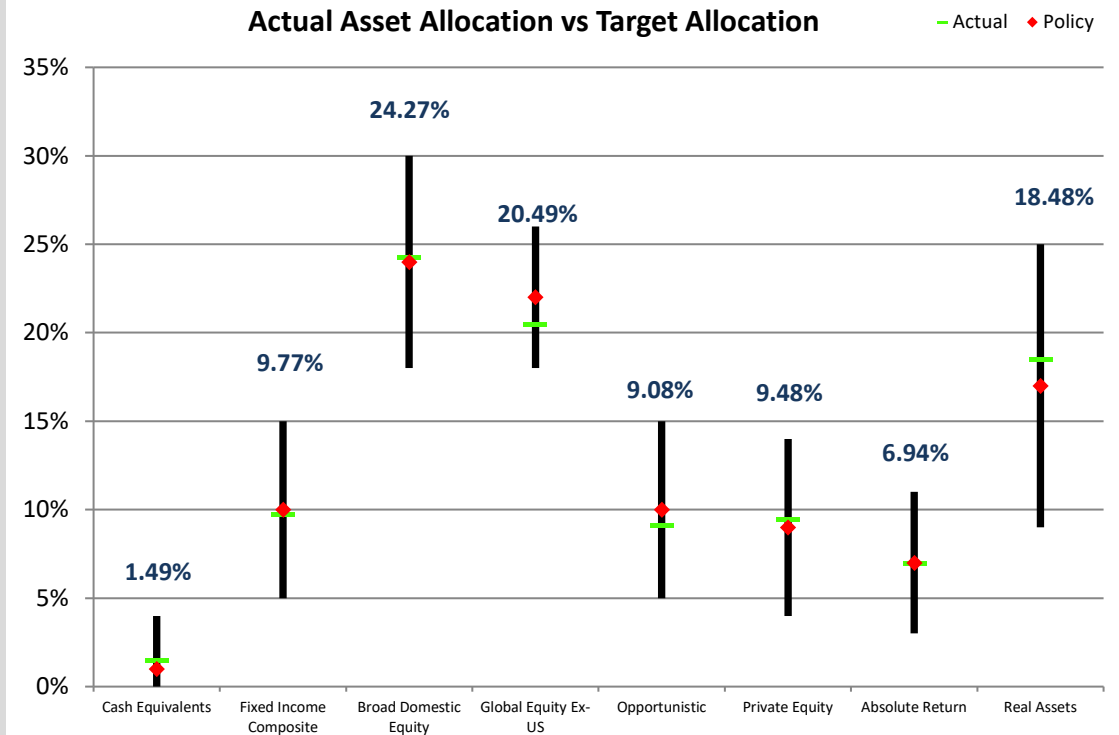
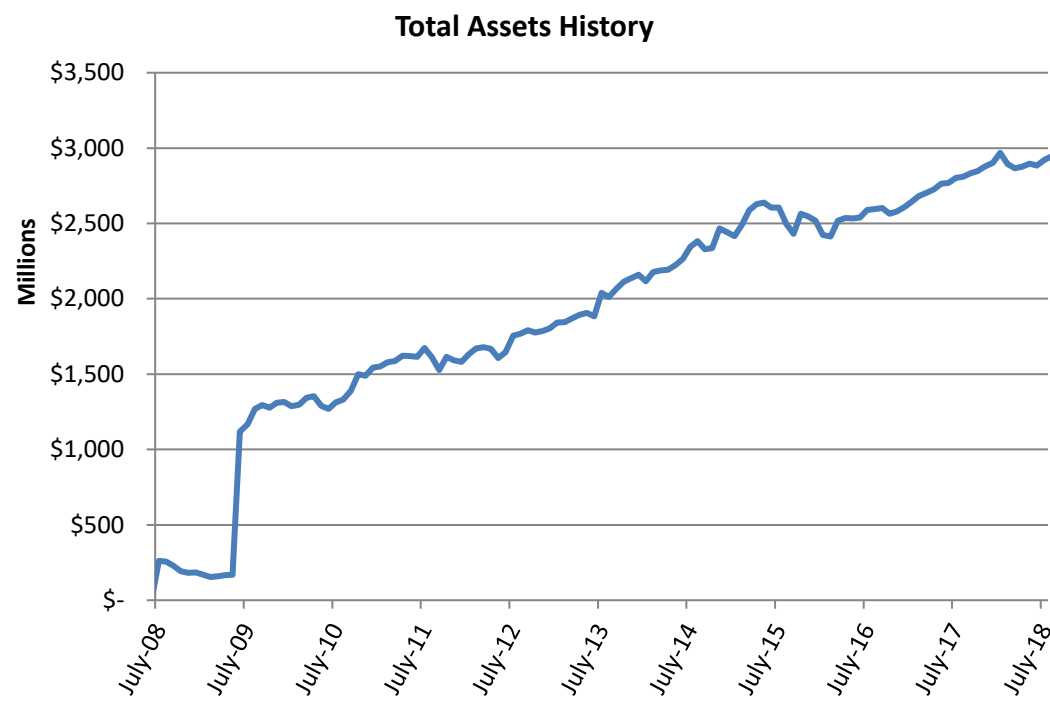
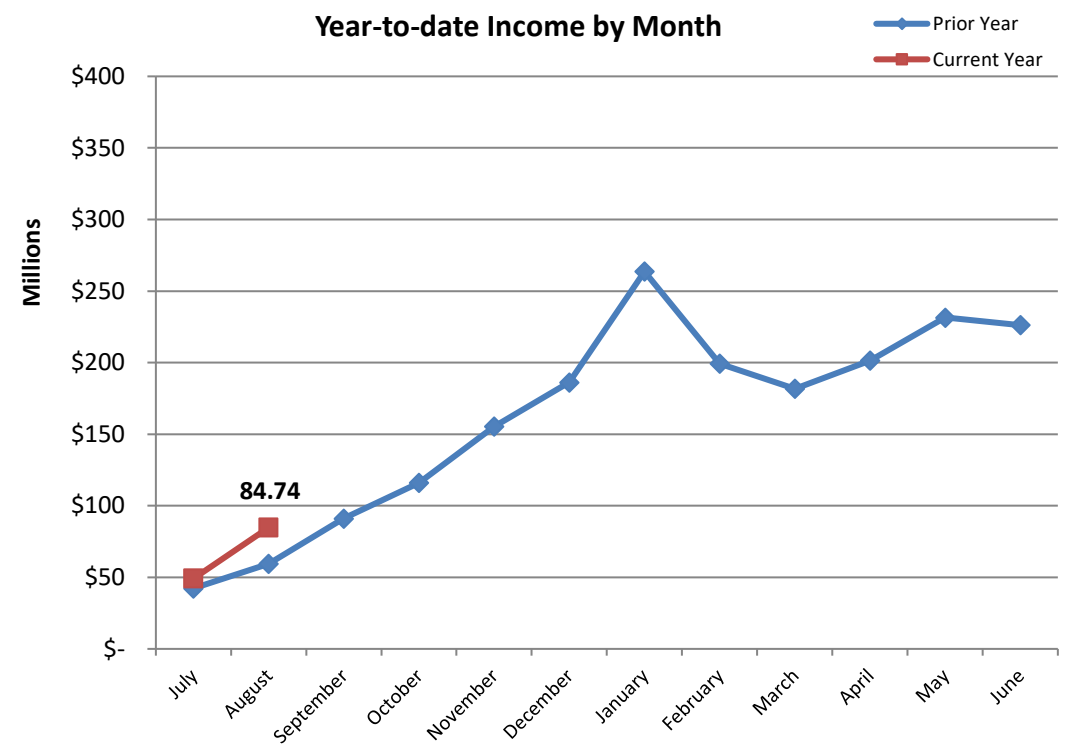
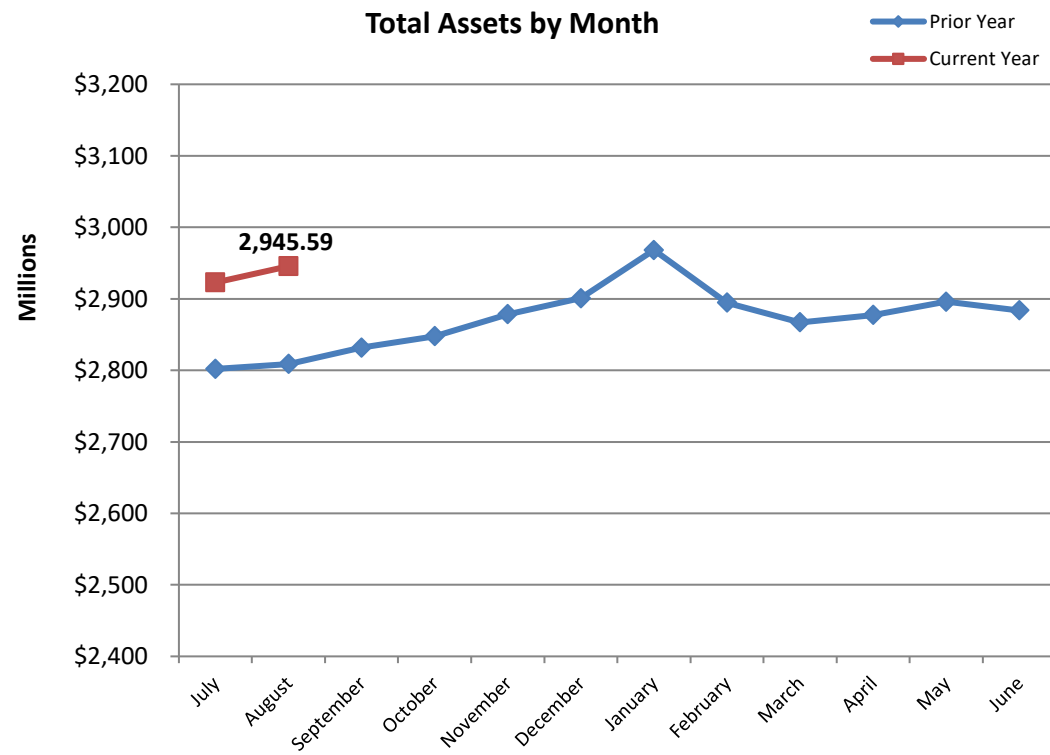


Teachers' Retirement Pension Trust Fund Fiscal Year-to-Date through August 31, 2018



Teachers' Retirement Health Care Trust Fund

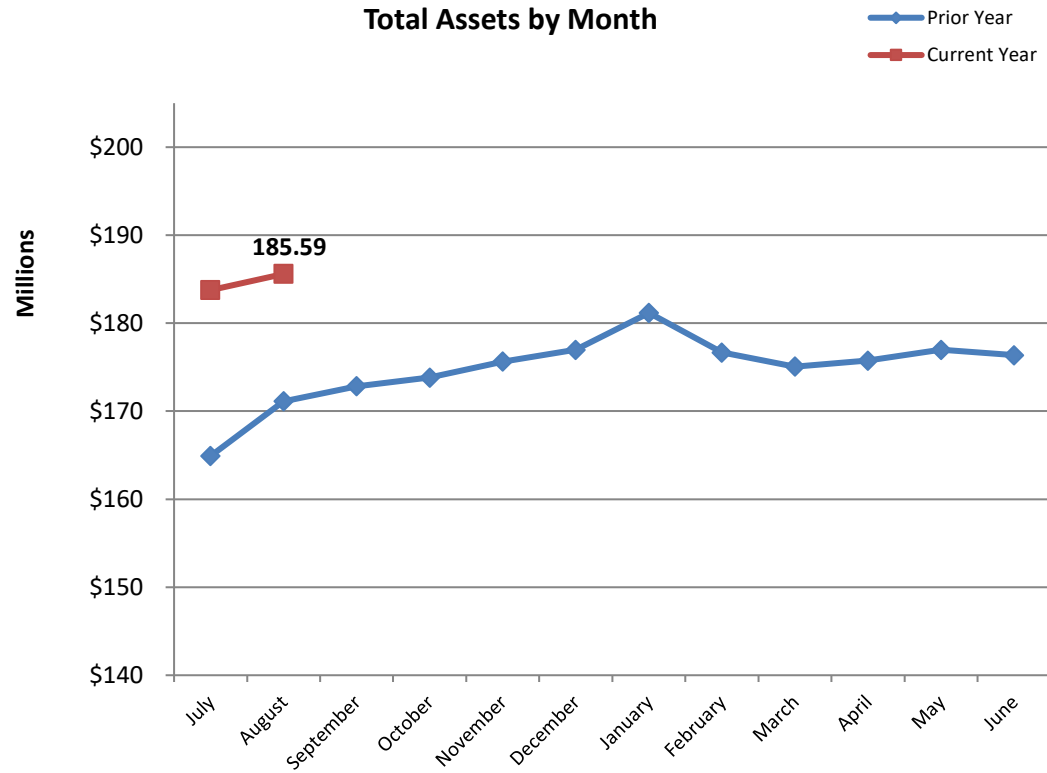
Fiscal Year-to-Date through August 31, 2018



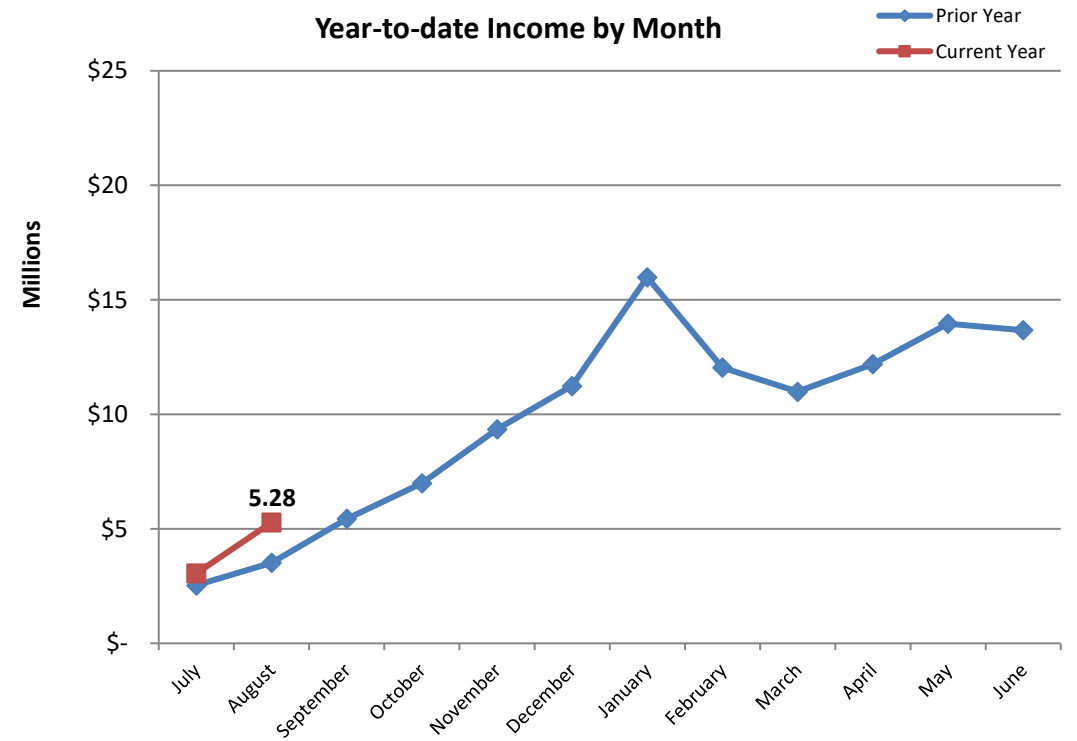
Judicial Retirement Pension Trust Fund

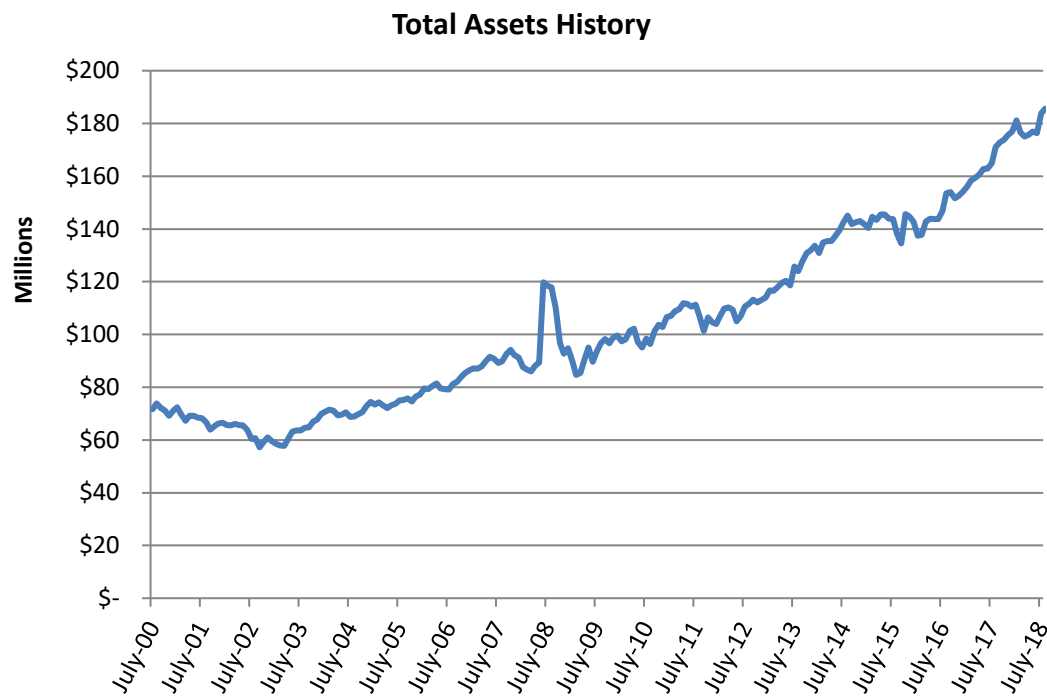
Total Assets by Month



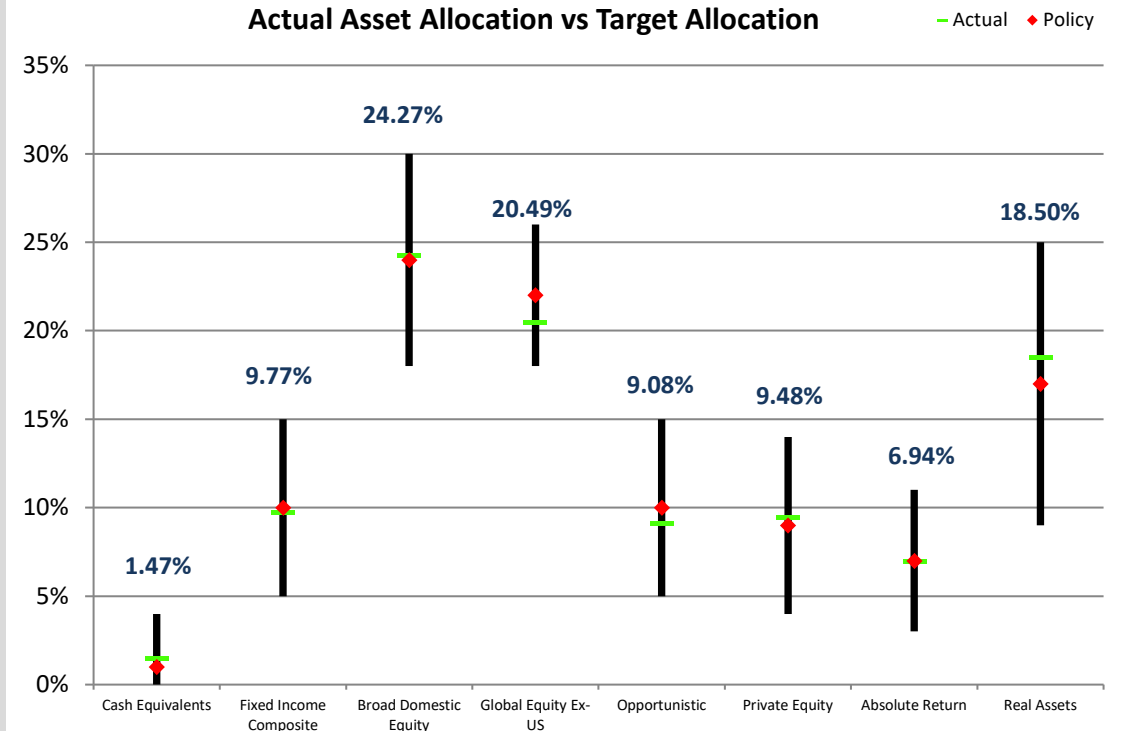
Year-to-date Income by Month

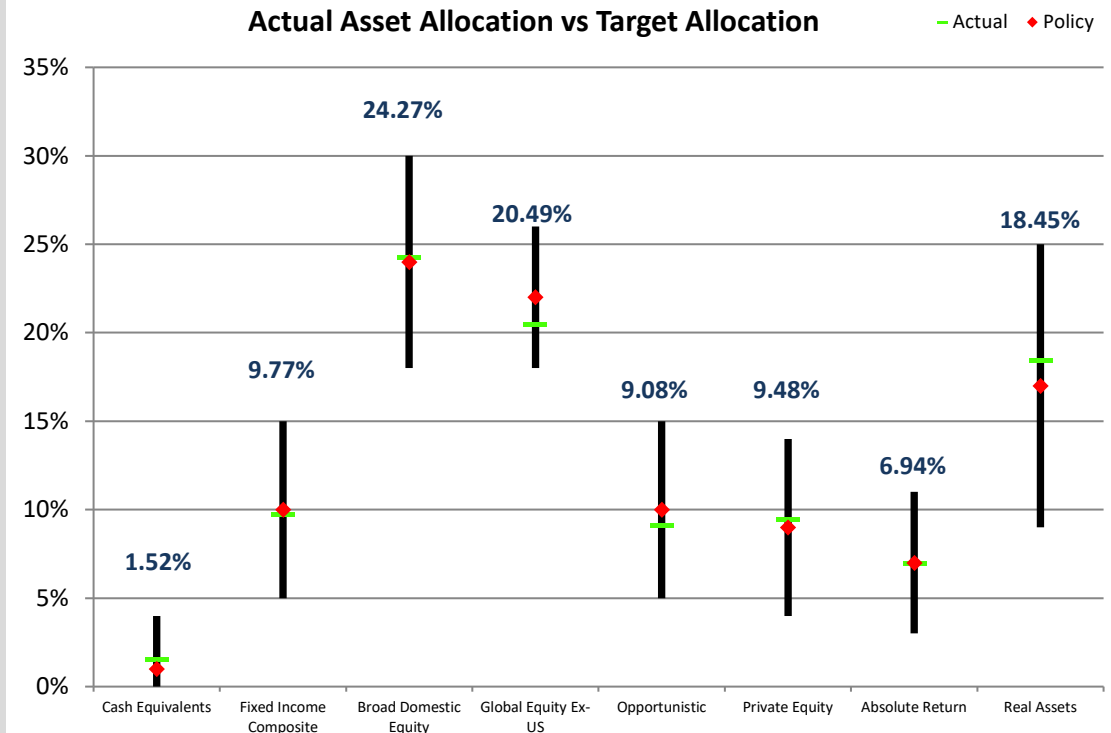
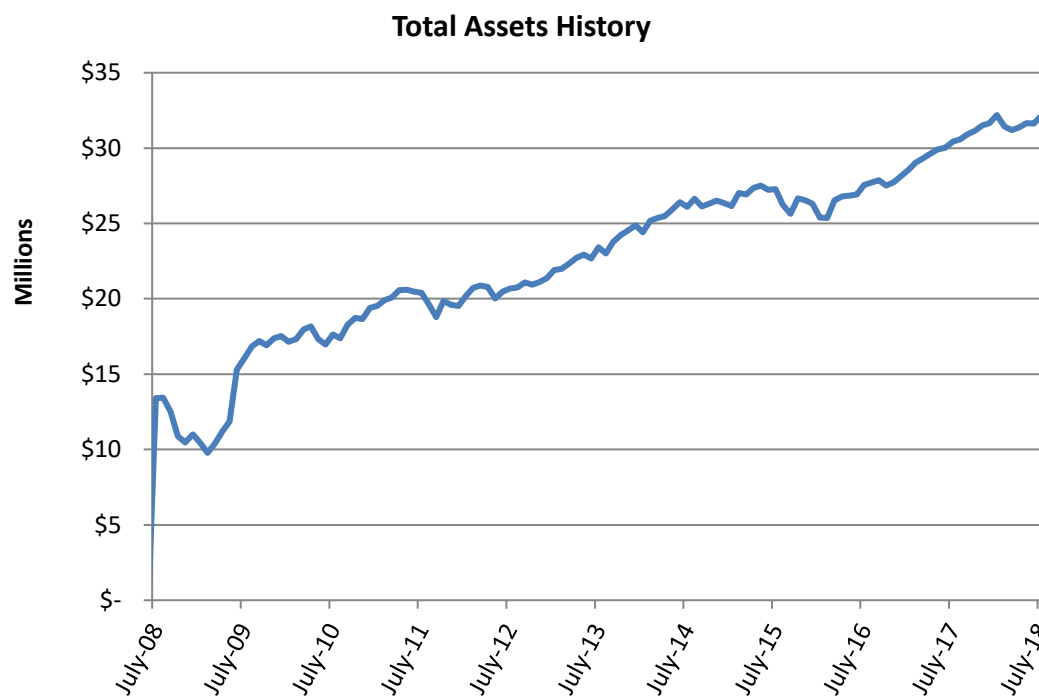
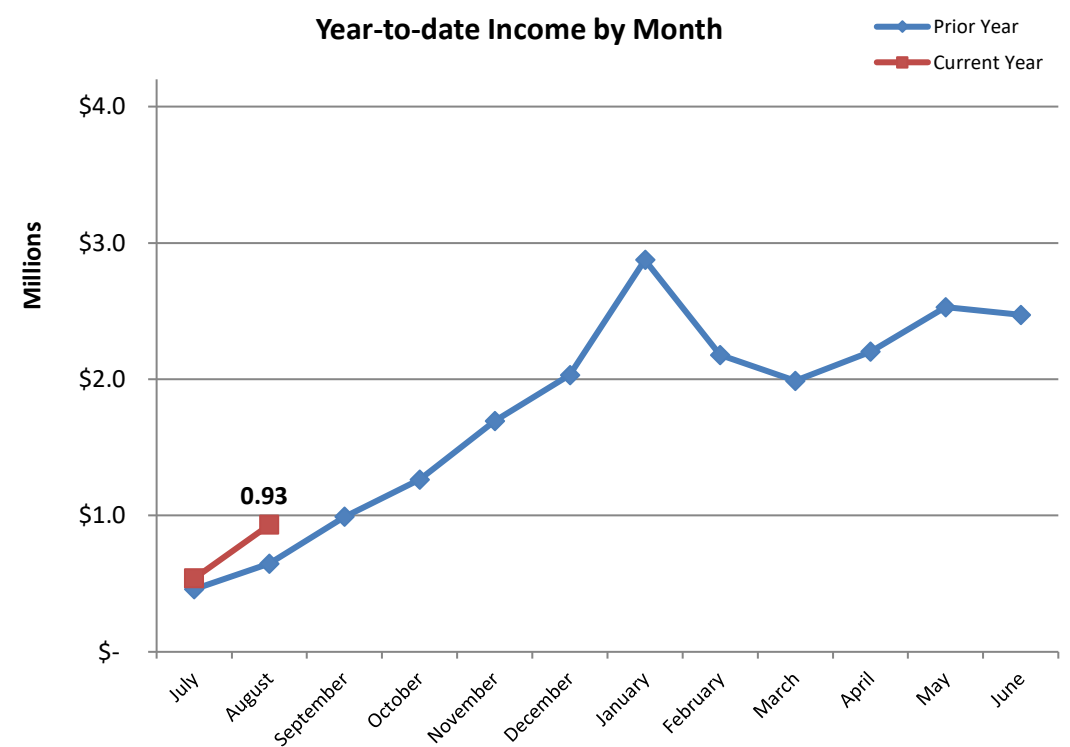
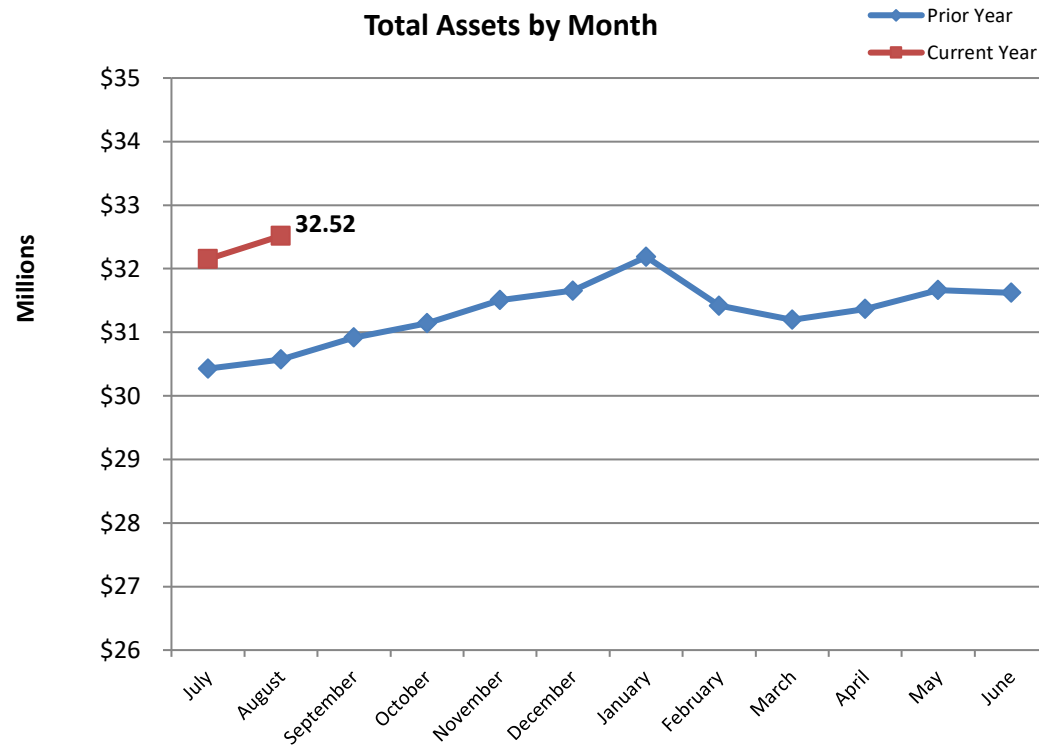


Actual Asset Allocation vs Target Allocation



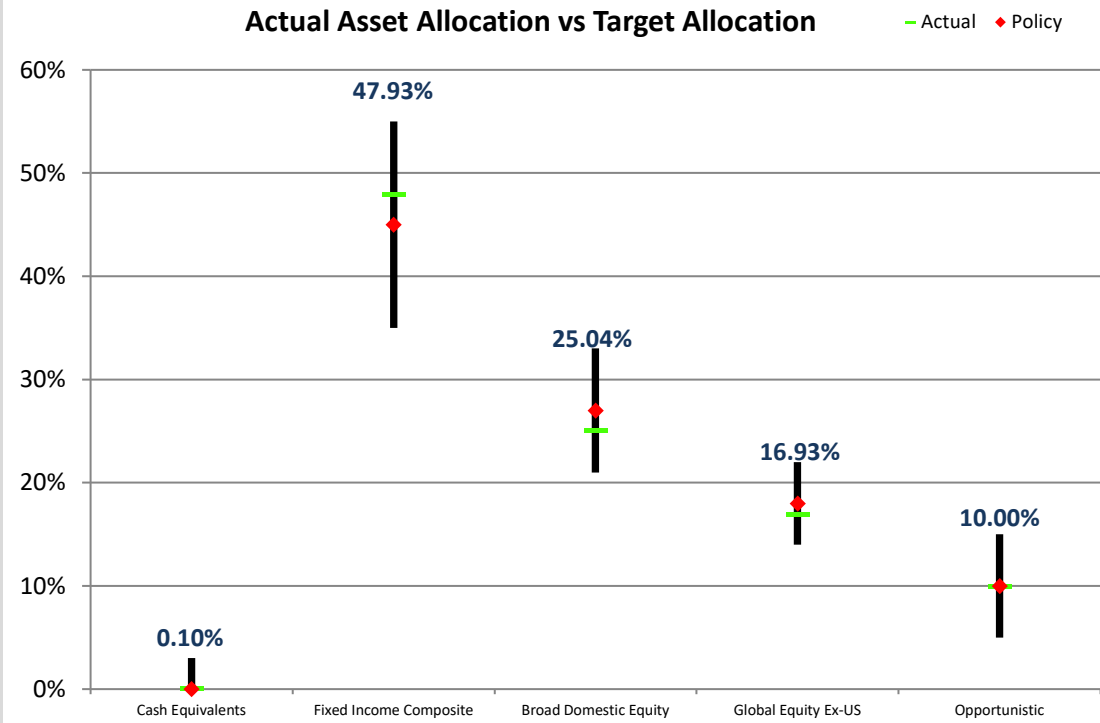
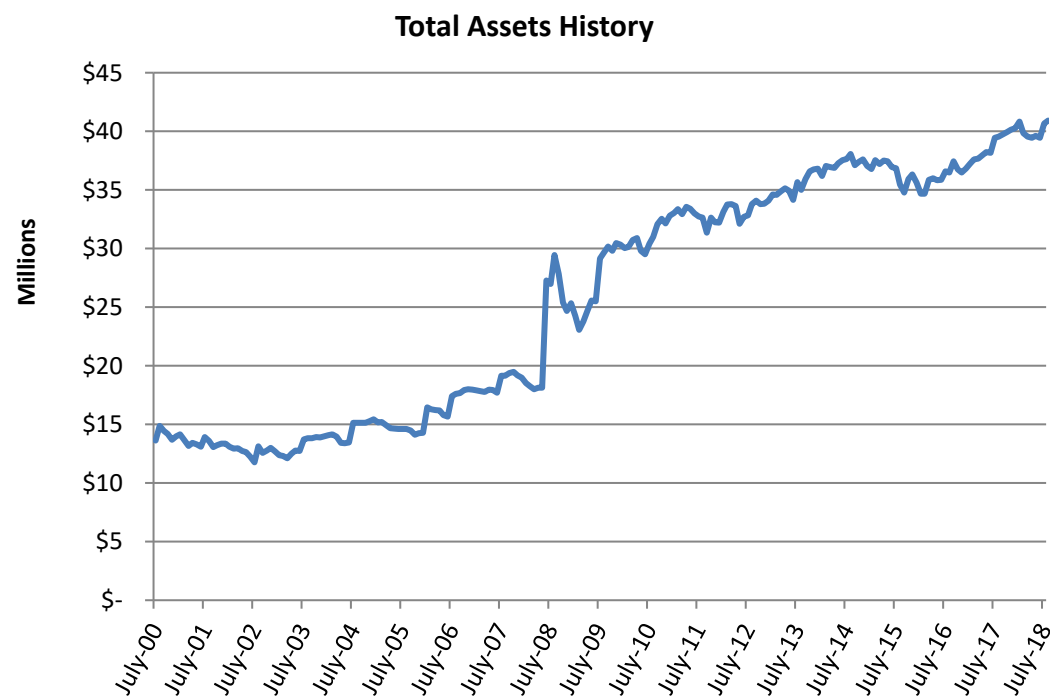
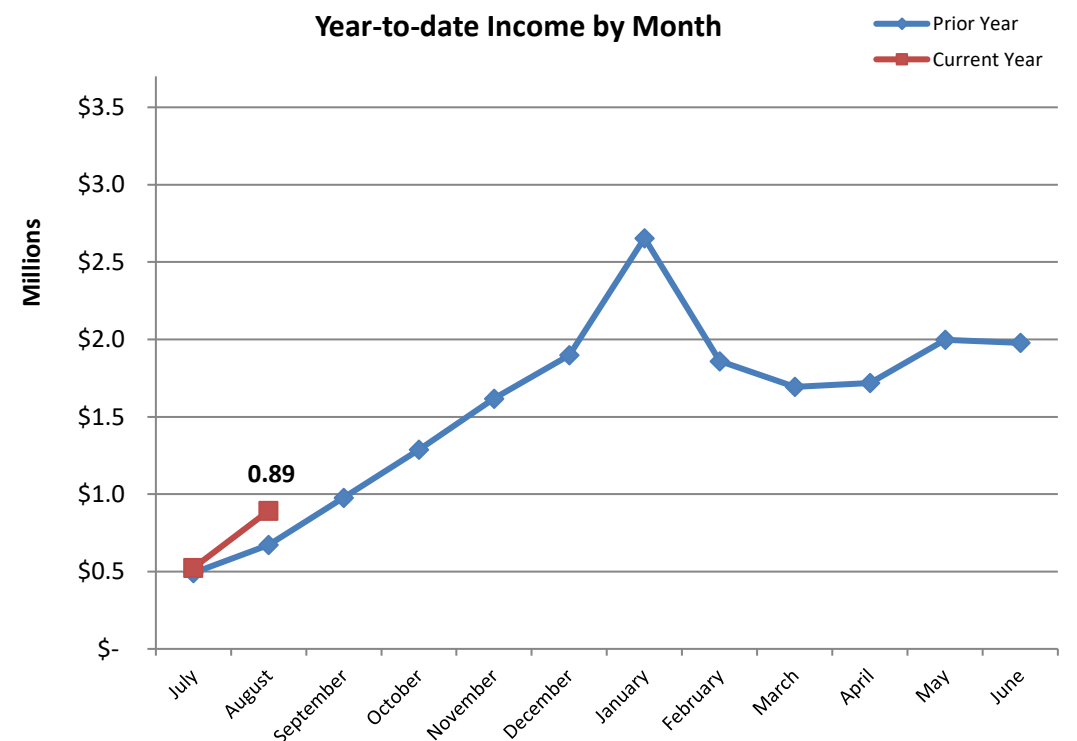
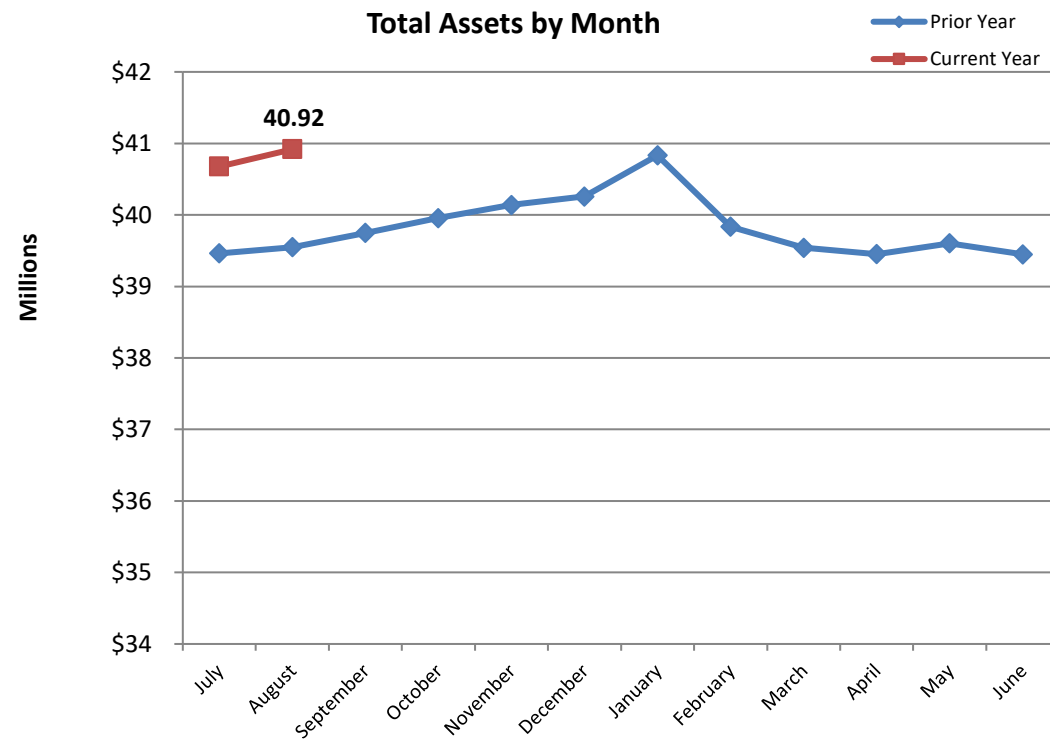
