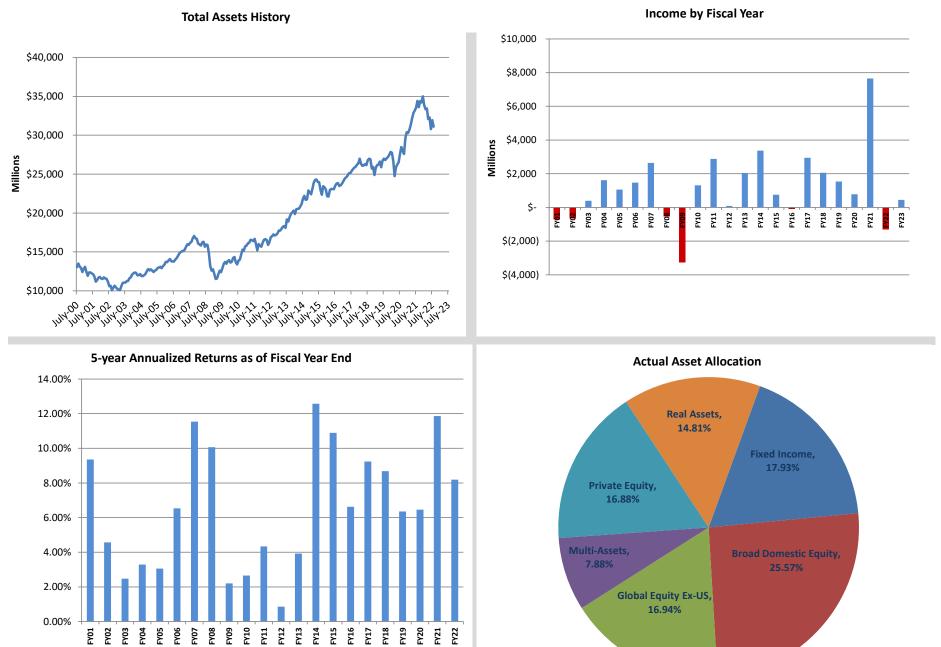

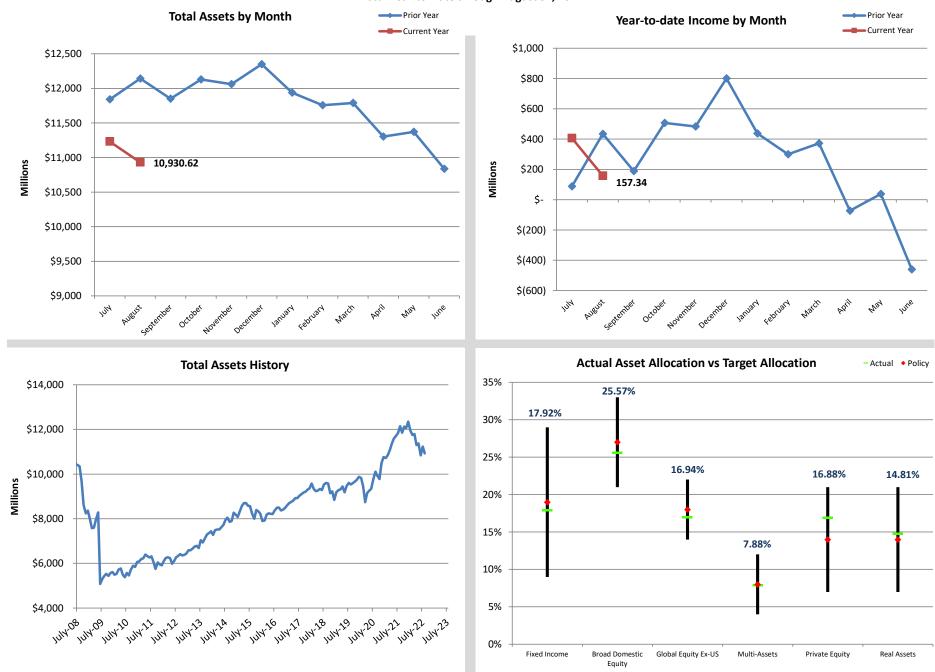
# **Total Non Participant Directed Assets**

As of August 31, 2022



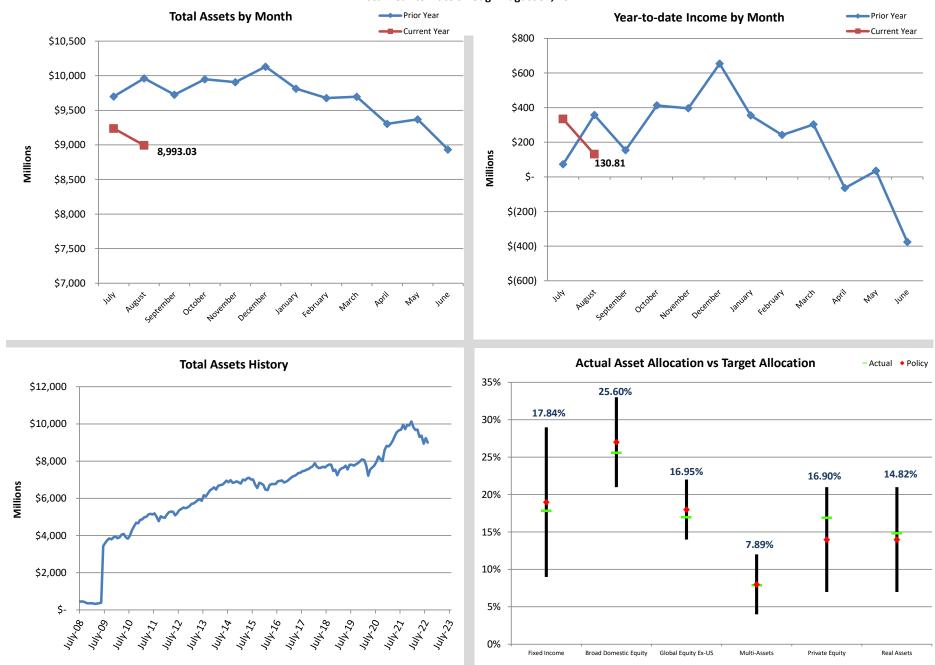
### **Public Employees' Retirement Pension Trust Fund**

Fiscal Year-to-Date through August 31, 2022



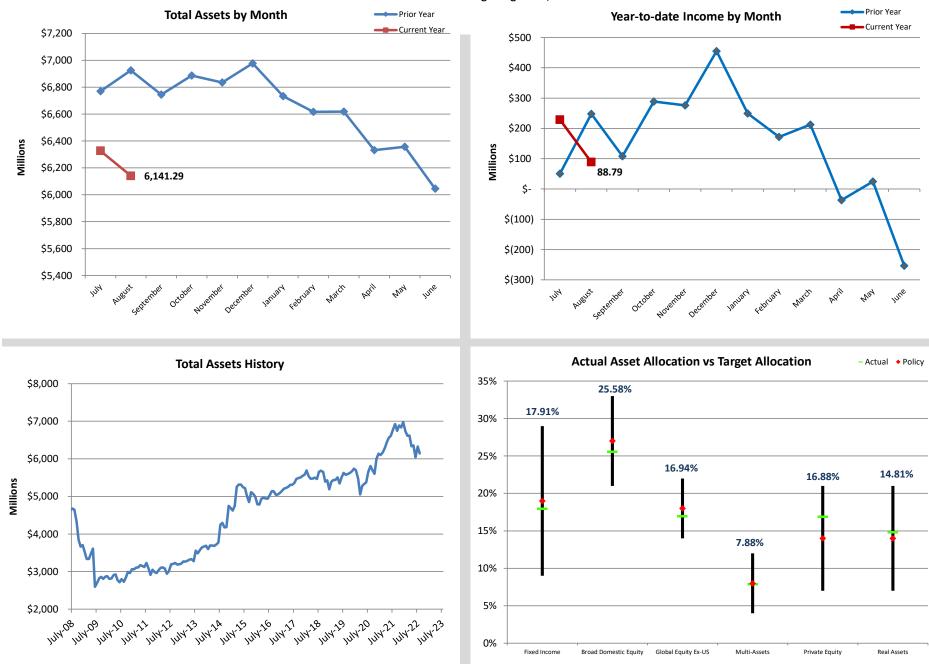
### Public Employees' Retirement Health Care Trust Fund

Fiscal Year-to-Date through August 31, 2022



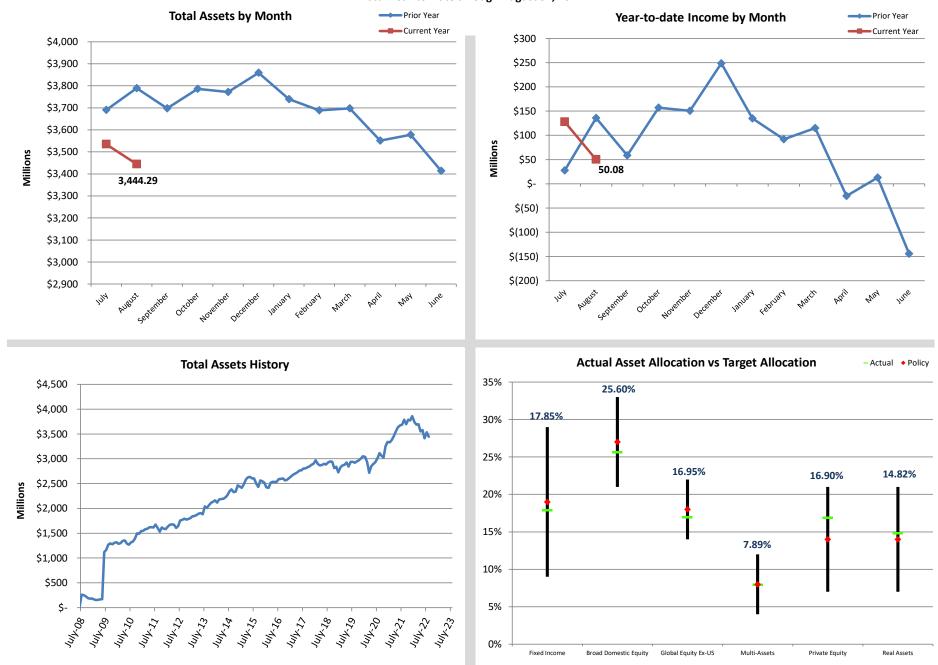
## **Teachers' Retirement Pension Trust Fund**

Fiscal Year-to-Date through August 31, 2022



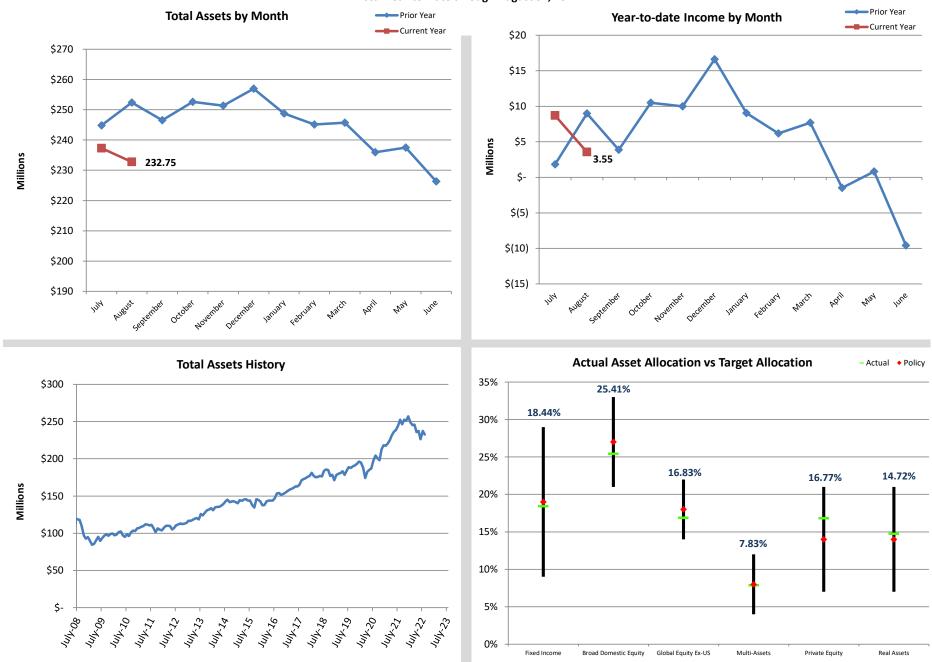

Fiscal Year-to-Date through August 31, 2022



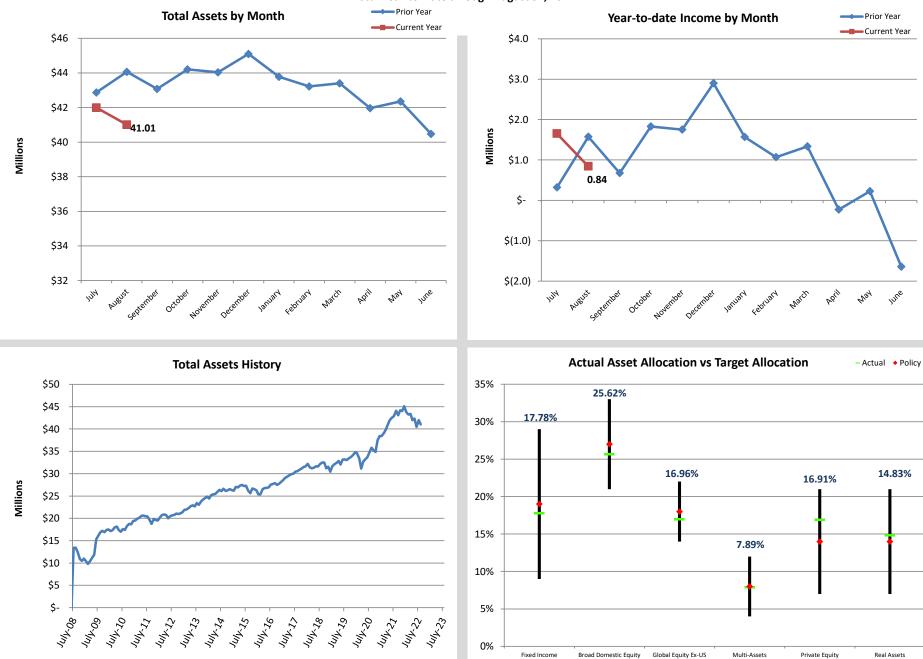
### **Judicial Retirement Pension Trust Fund**

Fiscal Year-to-Date through August 31, 2022



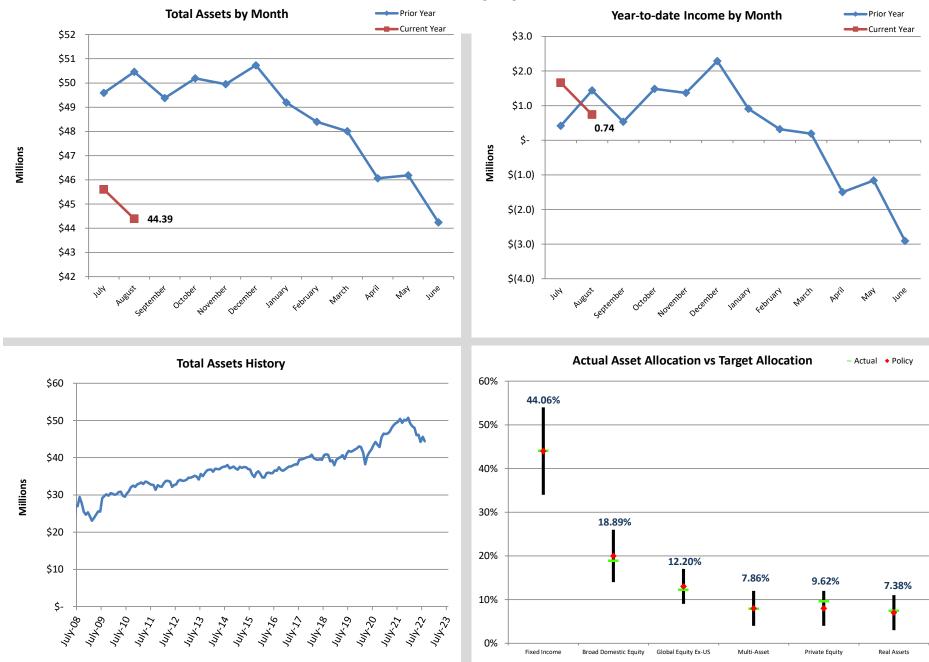
