

## General Fund and Other Non-Segregated Investments (GeFONSI)










## Constitutional Budget Reserve Fund (CBRF)









During April 2008 the CBR Sub Fund received contributions totaling \$4.1 billion. This was comprised of \$1.5 billion from the CBRF main account and \$2.6 pillion from the General Fund.
